As of 2024, our foundation proudly sponsors 70 students, allocating a total budget of \$140,000 to cover their public school education, resources, and food expenses annually. Through our initiatives, we strive to alleviate these pressures and pave the way for a brighter future for the youth in our community.





# IN REVIEW

On the Gold Coast alone there are over 40,000 children in High School, and it is estimated that at least 15% of this total are unable to fully afford the costs of a public school education, they are simply unable to provide the basics. That's over 6,000 not fully engaged with their education.

By helping to fund school essentials for children from disadvantaged homes and others in need, Enriching Lives Foundation hopes to encourage and enable kids to complete their schooling. Teenagers who leave school early are less likely to achieve employment, which may lead to social exclusion, mental health problems and future economic and social disadvantages within our community.

The Foundation was created to assist families in need, and the Sponsor A Student Program aims to cover public school expenses, including uniforms, school shoes, stationery, technology devices and excursions.

The funds to assist the students are given directly to the school. 'In need' students have been identified through a process by working with local schools – these schools currently include, Robina State High School, Miami High State School, Coombabah State High School, William Duncan Primary School and Nerang State High School.

By helping to fund school essentials for children from disadvantaged homes and others in need, Enriching Lives Foundation hopes to encourage and enable kids to complete their schooling. Teenagers who leave school early are less likely to achieve employment, which may lead to social exclusion, mental health problems and future economic and social disadvantages within our community.

School should be a place all children value and enjoy because they come to school dressed the same as their peers, they have ALL the resources they need and they fully participate in the opportunities that are available, equally.

### Gold Coast 2021 Snapshot 56,000 public school students

- 9% of the GC population
- extra 7,000 since 2016
- 12.5% increase
- 8400 or 15% can't meet the basic needs of food, uniforms & school

Of the 8,400 children who cannot access their basic needs for schooling, this does not include the many more who are excluded socially for not having the funds for the same clothes, shoes, and technology as their peers. Let alone join in on social events held at school, like their school formal.

The challenge of student engagement and mental health has become the number one objective for the education system. This community led program is administered by each public school and students are carefully selected by qualified teaching and welfare staff who personally know the students. Enriching Lives Foundation strives to raise the awareness of how many children miss out on reaching their potential due to the costs of public school education.

The Sponsor A Student Program aims to increase the number of businesses and individuals who give back by ensuring giving is making a direct impact on the communities in which we live by getting funds directly to students to improve their futures.
